Algeria has become a major player in the fight against counterfeiting, given its geographical location as a bridge between the European continent and Africa.

- Will allow to exchange and highlight the importance of the strengthening of cross-border cooperation through the exchange of information between institutions and authorities to limit the actions of counterfeiters and enable the preservation and protection of the respective public interests.
- Will also be an opportunity to highlight the new opportunities that are offered, such as agreements reached by Algeria following its accession to the AFCFTA or the creation of the new free zone between Algeria and Mauritania.

IP rights is a major challange as well as anti-counterfeiting to allow the development of a healthy, virtuous and productive economy.

The signing of a protocol agreement between the public and private sector will be a major step forward and allow an optimisation of the fight against counterfeiting and the promotion of IP rights in Algeria.

DETAILS ON THE TOPICS COVERED


- Counterfeiting is a scourge that has dramatic consequences and ravages entire sectors and sections of the formal economy. Counterfeiting represents a significant loss of revenue for public finances and to the creation and innovation.
- The Algerian Ministry of Commerce and Customs have set up a simplified regulatory system that allows to make the fight against counterfeiters simpler and cheaper for rights holders and Algerian taxpayers.
- The impact on the environment and ecology should not be overlooked. In deed, Algeria has made a major and considerable advance in the matter thanks to decree dedicated to the destruction of the counterfeit products. Projets related to the recycling and ecology of counterfiet products will be presented with pragmatic and conctere solutions to limite the impact of these dangerous and illicit products.
- Artificial Intelligence must not ne be left behind. The impact on our daily life and in term of regulation is unsuspected and unknown to the general public. The AI must be very quickly integrated into the reflection at all levels. AI experts will be able to explain and enlighten us on the direct conreerns we are facing and what to expect for coming years.
- The development of the African regulatory framework of DP rights between 2023 and 2024 deserves to be highlighted. These regulatory advancements allow to offer new business opportunities .

SHORT & MEDIUM TERM SOLUTIONS to be discussed

- Establishement of a framework law on anticountefeiting sould be considered.
- The Optimization and strengthening of cooperation in order to make the fight against counterfeiters more effective.
- The consideration of the Artificial Intelligence must be systemically at all levels of reflexions.
- The creation of an observatory for IP rights for the African zone dedicated to the fight against counterfeiting, labelling and certifications, must enable exchanges between the private and public sectors.
- The regulatory reform on patents, designs and trademarks, by introducing a system of opposition that should replace the current examination system.
- Continious training must be a priority. The public and private sectors as well as national and international offices must be able to exchange and train each other.
- The importance of GI (Geographical Indications), Standardisation and certification, must be highlighted, so that the national Algerian territory and heritage are recognised internationally at their fair value.
- Refelexion around the problems related to the registration of domain names and web hosting.
